EVALUIERUNGSKOMMISSION FREIBURGER
SPORTMEDIZIN

On June 6, 2007, the Former Rector Prof. Dr. Wolfgang Jäger appointed the „Unabhängige Gutachterkommission zur Evaluierung der Abteilung Rehabilitative und Präventive Sportmedizin des Universitätsklinikums Freiburg“ („Evaluierungskommission Freiburger Sportmedizin“).

In doing so, the rectorate reaffirmed its commitment to the most thorough investigation possible of the allegations (confirmed shortly thereafter) of systematic doping practices of sports medicine physicians in Freiburg, in particular for cyclists of the Team Telekom/Team T-Mobile.

Unlike the “Dopingkommission” set up at the same time specifically to investigate this affair, the Evaluierungskommission is examining the topic of doping and, in particular, the academic work of the Sports Medicine Department from 1970 to 2007, and will prepare a strength-weakness analysis.

Before concluding its activities at the beginning of 2012, the Evaluierungskommission will host the international symposium “Sports Medicine and Doping in Europe” on September 12-14, 2011. During this three-day event, leading experts in the field will present their research on international and local doping affairs in the context of sports policy and medicine and from scientific, historical, political, legal, and sociological perspectives.

The symposium will not officially address the results or current work being carried out by the Evaluierungskommission. Though the agenda will include talks by Evaluierungskommission members, their content is in no way intended to represent the views of the commission. Member contributions to the panel discussions are also to be understood as an expression of personal opinion.

The Sports Medicine and Doping Symposium is free and open to the public, but advance registration is requested.

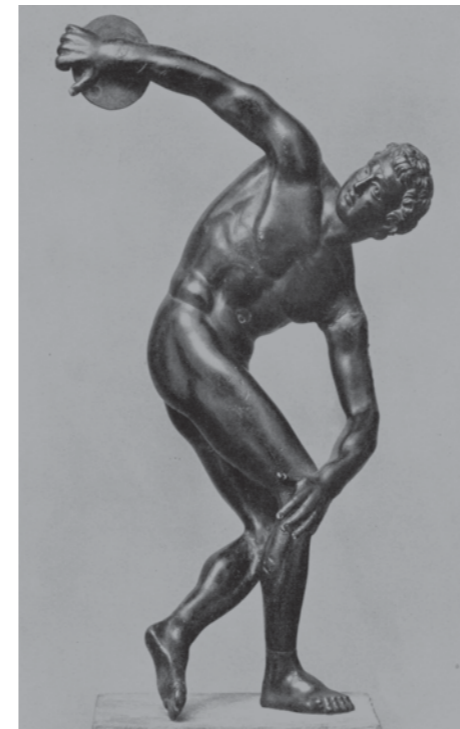
